## Grant Funding Application

### Zonta Club of Denver Funding – to empower women in the Denver metro area

**Purpose of Grant (eligible for funding):**

1. Support a new or on-going project for a 501(c)(3) organization.
2. Project focusing on directly improving the status and quality of life of Denver at risk women.
3. The funding must be used for projects within the Denver metro area that benefit local women.

**NOT Eligible for Zonta Club of Denver Grant Funds:** General operating funds, fund raising drives, capital campaigns, or any project promoting any specific religion, or political party and/or candidate. An organization that has received grants for three consecutive years will not be awarded another grant until after a minimum one-year funding recess.

The Zonta Club of Denver (ZCD) Service Committee reviews all complete applications meeting the above criteria and makes recommendations for disbursement. The recommendations are submitted for approval to the ZCD Board of Directors and to the Zonta Club of Denver Foundation (ZCDF) Trustees. The ZCD Board and/or the ZCDF Trustees may accept or change the Service Committee recommendations. Awarded funds will be presented at the ZCD Club meeting on Feb. 8, 2018.

**By accepting a grant from ZCD, the recipient agrees to:**

- Attend the club meeting in Feb. 2018 to accept the grant funds.
- Provide a written report in six months on the project’s successes and failures.
- Accept an invitation for a presentation to the Club about the project and the use of grant funds.
- Recognize ZCD as a donor in your public relations efforts within the community, on your website and in Newsletters. Also, include a link to the Zonta website on your website.
- **Support ZCD fund-raising 2018 Day of Film by purchasing or selling a minimum of 5 tickets (estimated at \$40 each) and publicizing the event to your board and supporters.**
